#### WINTER PARKING/ROADS

From November 1 to April 1, 2 AM to 9 AM, no person shall park or cause to be parked any vehicle on Town of New Glarus public highways or right-of-ways without the Town's permission, violators are subject to citations.

During winter snow storms, our patrolmen begin plowing at approximately 4 am until safety conditions are restored. Single or limited access roads are plowed after main roads are opened.

DO NOT PUSH YOUR SNOW INTO THE ROADWAY. According to Wisconsin State Statute §346.94(5) "No person shall place or cause to be placed upon a highway any foreign substance which is or may be injurious to any vehicle or part thereof."

If you are found pushing snow onto a public roadway or leaving your vehicle parked on a town road during a snowstorm, you may get a visit from the Sheriff's Department and a fine of \$50 for each occurrence. Please help keep our town roads safe this winter.

#### PROPERTY ASSESSMENT INFORMATION

Open book is the period of time, just after the Assessor completes the annual assessment roll, during which the assessments are open to the whole community. This will probably be scheduled mid-May 2020.

Board of Review is a formal hearing process for bringing concerns about the value of your property before the Town of New Glarus Board. In order to appear before the BOR, the property owner or owner's representative must file an objection form with the Town Clerk. The BOR will probably convene in early June 2020 for complainants to present evidence that has bearing on the value of their property.
